5. Library Director Report, Morgan Taylor, MLS

Circulation and Collections:

- February 2023 circulation totaled 2,940
 - Decrease of 5.8% from January 2023
 - Increase of 13.6% from February 2022
- 112 items were added to the collection and 214 were withdrawn

Facilities:

- Borough arborist suggested taking down 2 trees and trimming some overhanging branches. She has tagged them for DPW removal. Additionally, there is an evergreen we need to keep our eye on. Since the outside is the Borough's responsibility she has let Bil Jones know. It is unclear if this will be a charge that comes back to the library.
- The staff bathroom toilet has been repaired.

Finance:

- 4th quarter check from the Borough was received
- The Contemporary Club of HHK asked for an application from us in order to be considered a beneficiary
- The State Aid report has been filed

Staff News & Development:

 2 new staff members - Circulation Assistant and Marketing & Adult Program Coordinator

Programming:

- 110 participants spanning 7 programs in February
- March Madness style ballot in swing for New Jersians

Community Engagement:

- DVDs have been donated to the Christian Health senior care in Wyckoff. We have donated materials to them before
- Read Across America Day was on 3/2 both K. Cosenza and M. Taylor read at the elementary school.

Youth Services:

- K.Cosenza attended an in-person Summer Reading workshop.
- 6 programs in February 97 attendees.
